1. In these conditions and their interpretation, unless the context otherwise requires, the following terms have the specified meanings:

The 1990 Act:	The Environmental Protection Act 1990.
The 1995 Act:	The Environment Act 1995.
The Agency:	The Environment Agency.
The Site:	The land, structures, plant and equipment to which this licence relates.

The Licence Holder:

The Licence Holder specified in this licence or other person to whom the licence has been transferred in accordance with section 40 of the 1990 Act and section 120 of the 1995 Act.

The operator:

A person who is in occupation of the site and has responsibility for carrying out day to day activities at the site.

Relevant offences:

Offences within the meaning of regulation 3 of the Waste Management Licensing Regulations 1994 or any statutory provisions or regulations amending or replacing them.

Received:

For waste being delivered to the site, shall mean delivered to the site and undergoing the waste acceptance procedures specified in the working plan, including storage of those wastes during those procedures prior to acceptance of the waste.

Accepted:

For waste being delivered to the site, shall mean accepted as waste input to the site for storage and/or processing and/or disposal under the specified waste management operations.

Preparatory works:

Works required prior to the carrying out of the activities authorised by this licence.

Authorised officer of the Agency:

A person authorised in writing by the Agency pursuant to section 108(1) of the 1995 Act to exercise any of the powers specified in subsection (4) of that section.

Engineered:

For works specified in these conditions, means carried out and completed using the relevant engineering process specified in these conditions.

Engineering:

For engineering works specified in these conditions, means the relevant process of design, construction or installation, quality assurance or validation or commissioning specified in these conditions.

Engineer:

For engineering works specified in these conditions, means a person who works in the relevant branch of engineering, as a qualified professional.

Engineering survey:

A survey carried out in accordance with recognised or approved standards by a suitably qualified competent person.

Maintenance:

For engineering maintenance specified in these conditions, means the process of inspection, testing, repair of the relevant engineering works specified in these conditions.

Working Plan:

The working plan approved by the Agency at the time of issue of this licence and any subsequent amendments to it made in accordance with the conditions of this licence.

Immediately:

For carrying out of actions under the conditions, shall mean without delay and within a reasonable time, taking into account any more immediate direct action necessary to prevent or minimise risk to human health and the environment. For carrying out notifications to the Agency, shall also mean by the fastest effective means available (for example, telephone) and confirmed in writing within 1 working day (or such other time as may be agreed by the Agency within the conditions).

Waste:

Controlled waste as defined in section 75(4) of the 1990 Act and the Controlled Waste Regulations 1992 or any statutory provisions or regulations amending or replacing them.

Clinical waste:

As defined in regulation 1(2) of the Controlled Waste Regulations 1992 or any statutory provisions amending or replacing them.

Special waste:

As defined by regulation 2 of the Special Waste Regulations 1996 or any statutory provisions or regulations amending or replacing them.

Risk assessment:

The systematic identification, analysis, estimation and evaluation within a defined **scope** of the defined **risks** of a particular activity, operation, process or design, carried out and reported by suitably qualified or competent persons, using recognised quantified or semi-quantified methods and techniques.

Unless otherwise agreed by the Agency within these conditions, a risk assessment shall include and record the following:

- * definition of the **hazards** associated with an activity, operation, process or design;
- * assessment of the **probability** of those **hazards** occurring;
determination of the potential **consequences** of those hazards for defined **environmental targets or receptors**, taking into account defined **release pathways** and defined protective measures;
- * evaluation of the potential **magnitude** of those consequences and the **probability** of their occurrence.

Scope of risk assessment:

The boundaries of the **risk assessment** and the **risks** to be assessed within those boundaries, as defined in the conditions or otherwise agreed by the Agency within the conditions.

Risk: A combination of the **probability** and **consequences** of occurrence of a defined **hazard**.

Hazard: A property or situation that in particular circumstances could lead to harm.

Probability:

The quantified expression of chance, denoted either as:

- the ratio or percentage of the occurrence of a particular event as one among a number of possible events; or as
- the frequency of occurrence of a particular event in a given period of time.

Consequences:

For **risk assessments** carried out within these conditions, the adverse effects of harm as a result of realising a **hazard** which cause the quality of human health (other than health and safety of site staff or visitors to the site covered under the Health and Safety at Work Act 1974) or the environment to be impaired in the short or longer term.

Release pathways:

For **risk assessments** carried out within these conditions, the routes by which defined **hazards** may potentially realise their **consequences**, defined in terms of releases or emissions from the site that go beyond the site containment or boundary via one or more of the following routes, either directly or indirectly: **Land; Groundwater; Surface water; Atmosphere.**

Environmental targets or receptors:

For **risk assessments** carried out within these conditions, shall mean identified human and environmental populations or components, as specified in these conditions or otherwise agreed by the Agency within these conditions.

Groundwater: Any water contained in underground strata.

Surface water: Any lake, pond, river or watercourse whether natural or artificial.

- 2 The granting of this Waste management Licence is subject to the accuracy of the information supplied in the application form, working plan and supporting documents.

Any deliberate falsification of information may invalidate the licence and render the operator subject to legal action.

3. The conditions attached to this Waste Management Licence take precedence over any operational statements made in the application. Where anomalies are noted or contradictions occur, it shall be the duty of the licence holder to seek written clarification by the Environment Agency (the "Agency") before implementation.
4. In these conditions and their interpretation, the terms used, unless the context otherwise requires, shall have their defined meanings under waste management legislation, or else, by default, their meaning as understood by established best practices.
5. The waste management operations specified in Table 1 of these conditions shall only be carried out in the specified areas, within the specified limits of capacity and storage duration, and within the specified times.

6. No wastes other than those categorised in Table 2 of these conditions and specified in detail in Appendix A of the working plan shall be received. The quantities of waste received shall not exceed those listed or otherwise specified in Appendix A.

Notwithstanding the specification of permitted waste types listed above and whilst recognising that wastes of the types listed below may occur as admixture fractions of consignments of waste, they shall, nevertheless, not be accepted as discrete consignments:

- latex, latex/rubber solutions and suspensions;
- fats, waxes, greases;
- synthetic adhesive waste; and
- asbestos.

7. Whenever the site is open to receive waste it shall be supervised by at least one member of staff who is fully conversant with the requirements of the licence and the working plan regarding:

- waste acceptance and control procedures;
- operational controls and environmental monitoring;
- maintenance;
- record-keeping;
- emergency action plans;
- notifications to the Agency.

8. Any changes in the technically competent management of the site and the name of any incoming person together with evidence that such person has the required technical competence shall be submitted to the Agency in writing within 5 working days of the change in management.

9. In the event of the Licence Holder and/or any relevant person being convicted of any relevant offence (as defined in Regulation 3 of the Waste Management Licensing Regulations 1994 or any amendment to the aforementioned Regulation) and which is in addition to any already notified to the Agency, then full details shall be provided to the Agency within 14 days of conviction, whether or not the conviction is subsequently appealed. Such details shall include, in respect of each relevant person (as defined in section 74(7) of the Environmental Protection Act 1990 or any subsequent amendments to that section), the nature of the offence, the place and date of conviction, any sentence, and any fine or other penalty imposed.

In the event that the Licence Holder lodges an appeal against any such conviction, the Licence Holder shall notify the Agency of this within 14 days of the lodging. The Licence Holder shall notify the Agency of the results of that appeal, within 14 days of the appeal being decided.

10. The financial provision for meeting the obligations under this Licence set out in the Performance Agreement made between the Licence Holder and the agency dated 24 December 1999 shall be maintained by the Licence Holder throughout the subsistence of this Licence and the Licence Holder shall produce evidence of such provision whenever required by the Agency.
11. Except where it is specified under the other conditions of this licence that the amendment of specified sections of the working plan requires the prior written consent of the Agency, the Licence Holder shall give the Agency prior notice of any change to the working plan. Changes to the working plan will be implemented on the date specified to the Agency in the amendment notification.
12. The following information shall be notified in writing within 5 working days to the Agency:
 - (a) where the Licence Holder is an individual or named individuals in a partnership:
 - the death of the Licence Holder;
 - any steps taken with a view to the Licence Holder going into bankruptcy, entering into a composition or arrangement with creditors, or, in the case of a partnership, dissolving the partnership;
 - any change in the operator's trading name, registered name or registered office address (if different from the Licence Holder);
 - (b) where the Licence Holder is a registered company:
 - any change in the Licence Holder's trading name, registered name or registered office address;
 - any steps taken with a view to the Licence Holder going into administration, entering into a company voluntary arrangement or being wound up;
 - any change in the operator's trading name, registered name or registered office address (if different from the Licence Holder).

13. No preparatory works shall be undertaken unless at least 7 days notice in writing have been given to the Agency of the intention to do so. The notification shall include details of what work is being done and when.
14. No specified waste management operation shall be carried out until at least 7 days notice in writing has been given to the Agency of the intention to commence carrying out the specified waste management operation.

In the event that the site ceases all waste management operations either permanently or for longer than 5 working days then no later than 5 working days following the cessation of waste management activities the Licence Holder shall inform the Agency in writing of the date of cessation and the planned date of recommencement. In the event that the site recommences waste management operations sooner than the notified date then the Licence Holder shall give the Agency at least 5 working days notice in writing.

15. Except where otherwise specified, all notifications and submissions to the Agency under the requirements of these licence conditions:
 - shall be made in writing to the address specified by the Agency in writing at the time of issue of this licence, or as subsequently specified by written notification to the Licence Holder;
 - shall quote the licence reference number and the name of the Licence Holder.
16. No waste shall be deposited or handled in any area of the site until the engineered site surface and drainage system for that area has been constructed and completed to the written satisfaction of the Agency.

The engineered site surface and drainage systems shall be designed, constructed, validated and maintained, and shall be fully documented and recorded, to be fit for purpose and to meet the specified standards identified in the following documents:*

- Proposed Elevations & Section Drawing Number – Drawing Number 94990/107 Rev D.

17. No wastes shall be deposited, stored, treated or otherwise handled in any area for which an engineered site containment and drainage has been newly constructed until:

- details of the identities, relevant experience and relevant qualifications of the personnel who will be providing Quality Assurance of the engineered site surface and drainage systems have been submitted in writing to the Agency and acknowledged in writing by the Agency;
- the engineered site containment and drainage system has been constructed in accordance with Waste Management Licence Condition Number 16;
- the Validation Report confirming that the engineered site containment and drainage system meets the specified standards has been submitted in writing to the Agency and has been acknowledged in writing by the Agency.

18. All above ground tanks used for the storage of potentially polluting or hazardous waste liquids, sludges or powders shall be located within a bund. The plan and design of each bund shall be supplied to the Agency prior to the receipt of any wastes at the site.

The following specifications relating to the design, construction and maintenance of each bund shall be provided to, and acknowledged in writing by, the Agency prior to the receipt of any wastes at the site:

- materials;
- dimensions;
- capacities;
- impermeability;
- resistance to chemical attack;
- joints;

- construction Quality Assurance; and
- maintenance (Schedules, frequencies, actions and deadlines).

The design, construction and maintenance records shall be made available for inspection when required by an authorised officer of the Agency.

19. All drums and other mobile containers having individual capacities of greater than 10 litres which are used for the storage of potentially polluting or hazardous waste liquids, sludges or powders, shall be kept within silted areas. Details of the plan and design of the silted areas, including the following specifications, shall be provided to, and acknowledged by, the Agency, prior to the receipt of any wastes at the site:

- provision of storage;
- construction details and capacities of any silted areas;
- details of impermeable bases/floors; and
- maintenance schedules/frequencies.

20. Each tank used to hold potentially polluting liquids, sludges or powders, either as wastes or required with the treatment of wastes, shall be:

- loaded and unloaded in accordance with the specified filling and emptying procedures;
- clearly and unambiguously labelled regarding its contents;
- provided with means for measuring the quantity of material and the void space in the tank, which shall be maintained and calibrated as specified;
- monitored for quantity of material and void space and the monitoring measurements recorded.

The maintenance and monitoring records shall be made available for inspection when required by an authorised officer of the Agency.

Written procedures which will ensure compliance with these requirements shall be submitted to, and agreed by, the Agency, prior to the receipt of any wastes at the site.

21. Each drum or other mobile container used to hold potentially polluting liquids, sludges or powders, either as wastes or in connection with the treatment of wastes, shall be:

- loaded and unloaded in accordance with the specified handling procedures;
- filled and emptied in accordance with the specified filling and emptying procedures;
- unambiguously labelled regarding its contents;
- inspected according to the specified maintenance schedules and, in the event of damage or deterioration that is, or is likely to cause, a leak, shall be replaced immediately.

The maintenance records shall be made available for inspection when required by an authorised officer of the Agency.

Written procedures which will ensure compliance with these requirements shall be submitted to and agreed by, the Agency, prior to the receipt of any wastes at the site.

22. In the event of any potentially polluting leak or spillage occurring on site the control and remediation procedures specified in Section 5.2 of the working plan shall be implemented immediately. The incident shall be recorded and the records shall be made available for inspection when required by an authorised officer of the Agency upon request.

Any leak or spillage which may compromise the effectiveness of the pollution control regime and which either is leading or may imminently lead to pollution of the environment, harm to human health or serious detriment of the amenities of the locality shall be treated as an emergency, and the emergency action plan shall be implemented immediately.

(The emergency action plan shall be submitted to, and acknowledged in writing by the Agency, prior to the receipt of any wastes at the site.)

The Licence Holder shall give the Agency prior notice in writing of any proposed change to Section 5.2 of the working plan.

The written notice shall be supported by a written risk assessment of the effect of implementing the proposed change to Section 5.2 of the working plan on the risk of the site (to land, to groundwater, to surface water, and to humans dwelling or working in the vicinity of the site).

Any proposed change to Section 5.2 of the working plan shall not be implemented unless the Agency has given its written consent to it.

Following consent, the Licence Holder shall give the Agency prior written notification of the implementation date of the change, and from that date the changed section shall be incorporated in the working plan in replacement of the previous version of that section.

23. In the event that the permitted waste management operations on the site cease and the Agency has reasonable grounds to believe that they will not be resumed, all wastes remaining on the site shall be removed by the date specified in writing by the Agency.

24. No wastes shall be received at the site unless an identification board has been provided at or near the site entrance.

The identification board shall be inspected once each working day. In the event of damage or defect, the board shall be repaired or replaced within 7 working days.

25. Unauthorised access to the site shall be prevented by the site security systems provided, and maintained, in accordance with the following requirements.
- the site shall be fenced with a 1.8 metre high chain link fence, or in such a manner so as to provide a similar degree of security;
 - the site shall be kept closed and secure at all times when unattended; and
 - the site security shall be fully inspected at the commencement of each working day or as soon as is reasonably practicable, and findings recorded in the site diary. Any defects or damage shall be made secure by the end of the working day and shall be repaired within 7 working days of the damage being detected. All repairs shall be recorded in the site diary.
26. Whenever the site is receiving or despatching wastes, the following equipment shall be provided and maintained in good working order at the specified location, to prevent the deposit or tracking of mud or debris arising from the site onto public areas outside the site, which shall include public highways and areas of public access outside the site:

Equipment: Pressure washer with hand held lance

Location: As identified in Working Plan.

All vehicles leaving operational areas of the site shall be cleaned where necessary using the specified equipment and checked to ensure the security of the loads.

In the event that mud or debris arising from the site is deposited onto public areas outside the site, the following remedial measures shall be implemented immediately:

Road sweepers, or similarly effective equipment, shall be utilised at such frequencies and for such periods of time so as to clear public areas outside of the site and to maintain said areas free of mud and debris.

28. All fires on the site - except those which are specified operations under these conditions - shall be treated as an emergency and the actions specified in Section 6.10 of the Working Plan shall be implemented immediately.

The Licence Holder shall give the Agency prior notice in writing of any proposed change to Section 6.10 of the working plan.

The written notice shall be supported by a written risk assessment of the effect of implementing the proposed change to Section 6.10 of the working plan on the risk of the site to humans dwelling or working in the vicinity of the site.

29. Any proposed change to Section 6.10 of the working plan shall not be implemented unless the Agency has given its written consent to it.

Following consent, the Licence Holder shall give the Agency prior written notification of the implementation date of the change, and from that date the changed section shall be incorporated in the working plan in replacement of the previous version of that section.

All wastes shall be received, inspected, handled and despatched in accordance with the waste acceptance and control procedures specified in section Appendix B of the working plan. The specified records shall be made available for inspection when required by an authorised officer of the Agency.

Incompatible wastes which are likely, in combination with each other or with other material at the facility, to give rise to pollution of the environment or harm to human health outside the site, shall be clearly identified and kept physically separate, as specified in section Appendix B of the working plan.

The Licence Holder shall give the Agency prior notice in writing of any proposed change to section Appendix B of the working plan.

The written notice shall be supported by a written risk assessment of the effect of implementing the proposed change to section Appendix B of the working plan on the risk of the site to land, to groundwater, to surface water, and to humans dwelling or working in the vicinity of the site.

Any proposed change to section Appendix B of the working plan shall not be implemented unless the Agency has given its written consent to it.

Following consent, the Licence Holder shall give the Agency prior written notification of the implementation date of the change, and from that date the changed section shall be incorporated in the working plan in replacement of the previous version of that section.

30. Incoming wastes and outgoing wastes shall be weighed where necessary by means of weighbridge(s) which shall be located at locations identified in the Working Plan.

The weighbridge(s) shall be maintained and calibrated in accordance with the manufacturers' instructions, and shall measure quantities of wastes in tonnes to an accuracy of 0.01 tonnes.

The records of quantities received shall be made available for inspection when required by an authorised officer of the Agency.

31. Notwithstanding the other conditions in this licence, waste oils and oil-bearing wastes shall be handled in accordance with the following requirements:

- waste oils received at the site as an admixture to the domestic waste stream shall be handled in accordance with Section 6.5 of the working plan.
- oil-bearing wastes shall be handled in such a manner so as to prevent pollution of the environment, harm to human health and detriment to amenity.

Prior to the receipt of any wastes at the site, procedures relating to handling of waste oils and oil-bearing wastes shall be submitted to, and agreed in writing by, the Agency.

32. Notwithstanding the other conditions in this licence, liquid CFC containing waste items shall be handled in accordance with the following requirements:

- consignments of waste containing liquid CFC's shall be identified and dealt with in a manner consistent with preventing the uncontrolled release of the CFC content;
- CFC containing waste items shall be sorted separately prior to removal from the site.

Prior to the receipt of any wastes at the site, procedures relating to the handling of CFC containing waste items shall be submitted to, and agreed in writing by, the Agency.

33. Notwithstanding the other conditions in this licence, waste wet cell batteries shall be handled in accordance with the following requirements:

- wet cell batteries, whether received as an admixture fraction of the domestic waste stream or in discrete consignments, shall be stored, in a designated area, and in a container which is resistant to the contents of the batteries and in such a manner so as to prevent spillage or leakage of acid.

Prior to the receipt of any wastes at the site, procedures relating to the handling of waste wet cell batteries shall be submitted to, and agreed in writing by, the Agency.

34. Prior to the receipt of any wastes at the site, procedures relating to the handling of waste aerosol containers shall be submitted to, and agreed in writing by, the Agency.
35. Measures shall be implemented and maintained throughout the operational life of the site, in accordance with this condition and appendix D of the working plan, to prevent and minimise the release of airborne dusts, fibres and particulates arising from the site onto public areas outside the site, which shall include public highways and areas of public access outside the site and beyond the site boundary.
36. All emissions to air from the specified waste management operations on the site shall be free from visible concentrations of dusts, fibres or particulates as are likely to cause pollution of the environment outside the site boundary, as perceived by an authorised officer of the Agency.

In the event that any dusts, fibres or particulates arising from the site are released or are likely to be released onto public area and or outside the site boundary in such quantities or concentrations that they are likely to cause pollution of the environment, the actions specified in appendix D of the working plan shall be implemented immediately.
38. The following measures shall be carried out as the best practical means of preventing the release of odours outside the site in such quantities or concentrations that are likely to cause pollution of the environment, harm to human health or serious detriment to the local amenity.

Measures: all waste management operations to take place within the transfer station building and no wastes to remain on site, for a period in excess of 72 hours, unless indicated otherwise in Table 1

Monitoring: olfactory monitoring by specified person(s), 3 times (start, middle, finish) every working day.*

* Note: nothing in these conditions shall prevent monitoring being undertaken more frequently than specified if considered necessary by said specified person(s) or by authorised officer(s) of the Agency.

In the event that odours arising from the site are released outside the site in such quantities or concentrations that are likely to cause pollution of the environment, harm to human health or serious detriment to the local amenity, the following actions shall be implemented:

remedial measures - to be acknowledged in writing by the Agency prior to the receipt of any waste(s) at the site - to be implemented and if unsatisfactory, all wastes on site at time of incident which could give rise to odours to be removed from site as soon as is practicable.

The site shall be inspected for evidence of pests by a competent person at a specified frequency; said frequency to be agreed in writing with the Agency prior to any waste being received at the site. Litter control and collection measures shall be implemented in accordance with this condition and appendix D of the working plan, throughout the operational life of the site, such that any free litter within the site is collected, so as to prevent any litter escaping from the confines of the site.

- A summary record of the waste types accepted and removed from the site shall be made for each quarter of the financial year, and shall be submitted to the Agency within one month following the end of the quarter. The summary record shall be in a format agreed by the Agency in writing.
43. A site diary recording the following events shall be kept secure and shall be available for inspection at the site when required by an authorised officer of the Agency:
- start and finish of any construction works and certification;
 - start and finish of waste management processes;
 - plant maintenance and breakdowns;
 - emergencies;
 - problems with wastes received and resultant actions taken;
 - sampling exercises;
 - site inspections and the findings of same and any remedial responses;
 - dispatch of records to the Environment Agency;
 - weather conditions; and
 - environmental problems and subsequent remedial actions.

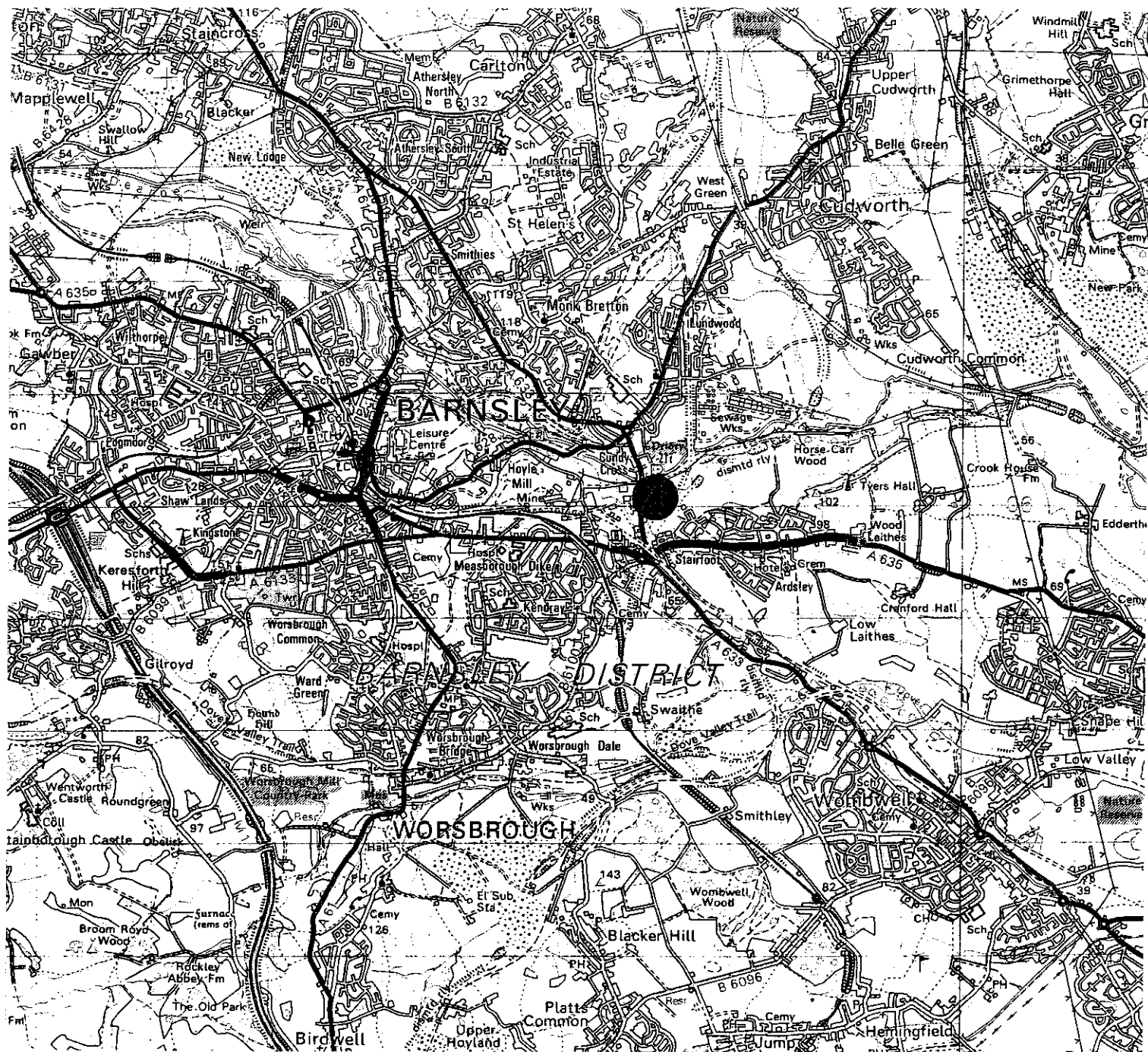

You are also required to serve a copy of your notice of appeal, together with copies of any of the above documents that have accompanied your notice of appeal, on the Environment Agency (at the address overleaf). You should appeal within 6 months of the date that this notice takes effect but the Secretary of State may allow notice of appeal to be given after the expiry of this time period.
